- 6. You must submit the desired financial reports on a defined periodic basis on LIC HFL stipulated template (Monthly Statement of Expenditure, Quarterly Audited Utilisation Certificate, Quarterly Narrative Report).
- 7. Subsequent tranche shall only be provided in case of quarterly satisfactory field visits conducted by the LIC HFL team.
- 8. Additionally, you are requested to fill in the required details and share the legalized affidavit draft and vendor registration for <u>review</u> to <u>YASH.JAIN@lichousing.com</u> before finalizing and sharing the notarized

hardcopy of the affidavit document on 100 Rupees stamp paper on or before **5/9/2025** with the stipulated attachments/annexures (Project Proposal, Monthly Work Plan, Budgets, KYC Documents of Board members duly signed and stamped and Reporting Pattern) to the following address:
